Treated all external areas with a fipronil based insecticide including pillars, railings, eves and also pavers. Internally no obvious signs of ants but nuisance webbing spiders in number. I've applied a safe residual insecticide to all skirting boards. Treated behind free standing appliances and furniture with permethrin dust. Gel baited kitchen and bathroom cabinets for cockroaches. Treated cornices as far as reasonably practicable given the height, with aerosol based insecticide. Highly recommended cutting the fig tree back so it's not in contact with the building, this will stop pests using it to gain access, but also help prevent damage to the building structure.

Full control of ants may take a few days but there should be a significant improvement.
